Late filing:

We did participate in a couple larger events during the 2016 primary but we're mostly a kitchen table organization.

As acting treasurer, I am responsible for submitting this report. Our elected treasurer moved some time ago and we've really had no one willing to take on the position. I hadn't been involved for several months so wasn't aware we were without a treasurer until we gathered to address postcards. I agreed to take on the duties of filing the required quarterly reports until we could officially elect another treasurer. This ballot question report info was forwarded to me to see what we needed to do.

Granted, our lack of sophistication doesn't exclude us from following the rules. I relate this information as a way to explain our failure to meet the July 18 deadline. We are on target to file the next ballot question reports as well as our usual quarterly reports. Also, we will file an updated organizational report when we next meet officially to elect a treasurer and secretary.

Please accept our apologies and I hope no punitive action will be filed against our organization for our failure to file these reports in a timely manner.
