Re: Amendment to Campaign Finance Report for the period 1/1/16 through 7-21-16

This amendment is necessary due to the omission of names from the initial filing. The attached summary and schedule represents the names and information from those supporters who were omitted from the initial report filed July 25, 2016. There was also an error in the addition from the previous report. The previous contribution total was \$30,415.00, however, only \$28,915.00 in contributions were listed in the Schedule A. After taking into consideration the addition error and the omitted names, the new total is \$31,815.00. A total of \$2,900.00 of contributions was omitted, which combined with the previous actual total of \$28,915.00 represents a total contribution amount of \$31,815.00 for the subject period.
