1. K.S.A. 25-4146(b) states, "No contribution or other receipt shall be received or expenditure made, by or on behalf of a candidate, except payment of a filing fee: (1) until such candidate appoints a treasurer and makes the report required to the Secretary of State..." . Several expenditures were made before the appointment of treasurer form was filed on September 17, 2010.

These expenditures should not have been made. No amendment to the October 25, 2010 report is necessary. This notice is being provided for informational purposes.

2. According to the reports filed with the Secretary of State, the Kansas State Rifle Association PAC reports making a \$100 contribution to Willie Dove on 10-11-10. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 25, 2010 report.. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.

3. Schedule C (Expenditures and Other Disbursements) of the October 25, 2010 report lists an expenditure to Metro Ford, Inc. on 10-1-10 for a "Ford Mustang Used In Parade". However, an amount for this expenditure is not listed. An amended Schedule C must be filed listing the amount of this expenditure.

4. The cover summary page of the October 25, 2010 report lists the cash on hand at close of period as \$2157.46. However, the contributions listed on Schedule A (Contributions and Other Receipts) total \$2300.00 and the expenditures listed on Schedule C (Expenditures and Other Disbursements) total \$2144.10 which leaves a cash balance of \$155.90. An amended report must be filed explaining this discrepancy of \$2001.56 on the cover summary page.
