I discovered an error in the calculations for the Ward/Thull golf event held in 2006. The total expenses were overstated by \$100. On previous reports both Rep. Ward and I reported golf tournament income of \$1621.

Because I have moved out of the 72nd District and will not seek re-election. The golf account was closed and the \$100 that remained due to my miscalculation was given to Representative Ward. It would be difficult if not impossible to attribute the additional \$100 to any single contributor.

Representative Ward advises me he has included the \$100 in the unitemized contributions on his July 28, 2008 Campaign Finance Report.
