Dear Ms. Williams:

This letter is in response to your notification letter dated July 1, 2008 concerning your "Notification of a Material Error or Omission in a Receipts and Expenditures Report".

The initial report dated January 9, 2008 contained two errors. One error concerned the receipt of a \$250.00 contribution from KC Power & Light PAC-Kansas which was inadvertently left off of Schedule A. This in turn caused Line 2 in Section C – Summary to be incorrect; thus flowing through the summary and understating the Campaign fund's Cash on Hand (Line 5 of Sections C). The amount originally shown on Section C, Line 5 for Cash on hand at close of period was \$14,176.43. The correct amount should have been \$14,426.43. This has been corrected on the revised Schedule of Receipts and Expenditures of a Candidate for State Office – January 10, 2008 which is attached.

The second error was a result of not carrying forward a loan made by the candidate, Forrest Knox, on Schedule D. The loan was made to the campaign fund in May of 2005 and was inadvertently left off of Schedule D for the January 10, 2008 reporting period. This also has been corrected and is now shown on Schedule D of the revised report which is attached. The total amount shown on Section C – Summary, line 7 was \$37.40 and is now revised to show \$2,037.40 to tie to Schedule D on the revised report.

I apologize for the errors and hope the revised filing is acceptable.
