In your letter to us, dated August 26, 2008, regarding Notification of Material Error or Omission In a Receipts and Expenditures Report for July 28, 2008, three points were inquired about. Below are the clarifications and corrections.

Also, I received this letter late from you because I have changed the my mailing address. It was previously sent to 771 N. Mt. Carmel, Wichita, Ks 67203, but my "new" mailing address is 641 N. Mt. Carmel, Apt. C Wichita, Ks 67203. We have updated it on-line on the new system to update an appointment of a campaign treasurer. A copy is enclosed. My apologies for just getting back to you today on this very important matter.

1. Schedule A (Contributions & Other Receipts) of the July 28, 2008 report, the amount of \$329.47 for unitemized contributions of \$50 or less was mistakenly put in two places. The necessary changes have been made, by removing one of the entries and have amended the cover summary page with the correct total for total contributions & receipts.
2. The Garcia Campaign only received one \$300 check from Phil Ruffin, but we accidently reported it twice, once before on the previous report due to the fact it was dated Sept. 19, 2007, but was not received until late December right before the closing date deadline, hence having us deposit the check in early January with Samuel Williams \$100 check dated December 26, 2007. We reported both checks on the January 10, 2008 report AND the July 28, 2008 campaign finance report. The problem was that we mistakenly reported them twice, when it should have just been reported once in one report. This amount has been adjusted accordingly on the cover summary page. A copy of the check received and deposit date is enclosed.
3. A copy is enclosed of the check from the Kansas Contractors Assoc PAC dated August 19, 2008, along with a copy of the envelope dated September 9, 2008 as well as with the top of the letter that accompanied it dated September 9, 2008. There was in fact a \$500 contribution made to us, but not on June 24, 2008.




