This letter is offered as a response to your letter of September 30, 2008 concerning mistakes we have made handling receipts associated with a survey we mailed to individuals earlier this year. The survey stated if the recipient wanted to help pay some of the postage and printing costs incurred producing and mailing the survey, they could send in what ever amount they wanted. We received quite a few small checks and some cash.

You should find enclosed with this letter an amended receipts and expenditures report through July 28, 2008. I would like to address the two matters you brought up in your letter of September 30.

1. <u>Contributions received during the session not made by an individual.</u> You listed nine contributions that could not be determined from the name of the contributor whether they were from individuals. We have returned six of those contributions and explained one. We have not returned the receipts from The Singularis Group because they were refunds of overpayments we made, not contributions. We worked with The Singularis Group to produce, address and mail the survey. I have attached a worksheet to show our somewhat confusing payments to and from that service provider. I have also enclosed copies of the checks we received from The Singularis Group of \$64.88 and \$684.24. Both of these were payments to the campaign account for overpayments we made to The Singularis Group. The \$684.24 was somewhat planned by The Singularis Group as the method they wanted to use to handle the postage through the state printing office.
