Query: K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee. . .shall not exceed the following: for member of the house of representatives, ... \$500 for each primary election...and an equal amount for each general election." The Kelton campaign reported receiving a \$500 contribution on 8-6-08 from the Plumbers & Pipefitters Local Union #441 and an additional \$500 on 9-24-08. These contributions were received during the general election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2010 Receipts and Expenditures Report.

Response: *Review of our records indicates that the \$500 contribution listed on 8/06 for Local #441 was incorrect. The \$500 contribution was actually from the NE KS Building Trade PAC fund, Laborer's # 1290. The August 6 check was incorrectly reported as coming from the Plumbers & Pipefitters Local Union # 441. No revision was needed to account for a difference in the contribution amount on Schedule A – only the change in the contribution's source. See attached copies of checks for verification.*

Query: According to the reports filed with the Secretary of State, Sheet Metal Workers Local # 29 PAC reports making a \$100 contribution to Stephanie Kelton on 7-30-08. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A. (Contributions and Other Receipts) on the October 27, 2008 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.

Response: *We are unable to confirm the receipt of the \$100 contribution from the Sheet Metal Workers Local # 29 PAC. (i.e., no copy of the check). However, we were over this amount when we filed our Campaign Finance Report on October 27, 2008. Since we were unable to determine the source of the contribution, we accounted for these funds in our \$635 Total Unitemized Contributions.*

Primary Reporting Period

Query: K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee. . .shall not exceed the following: for member of the house of representatives, ... \$500 for each primary election...and an equal amount for each general election." The Kelton campaign reported receiving two \$500 contributions on 8-01-08 from the Kansas State UAW PAC. These contributions were received during the primary election period.

Response: *Review of our records indicates that one of the \$500 contributions from the Kansas State UAW PAC listed for this reporting period had an incorrect date. The date for the first \$500 contribution was 08/01/08 (as reported). However, the second contribution was made on 9/29/08 (not 08/01/08 as we reported). See attached copies of checks for verification.*
