This letter constitutes amendments to the Bruce Cooper Campaign's October 27, 2008 and January 10, 2009 Receipts and Expenditures Reports.



Regarding expenditures made to Rachelle Netzer, a student majoring in political science at the University of Kansas and a resident of Lawrence, the following information is offered. The money paid to Ms. Netzer was to compensate her for tasks performed for the campaign and to reimburse her for costs incurred in driving between Lawrence and Topeka. A number of times she made more than one trip in a day's time. Among the tasks were:

- Maintaining lists
- Researching issues
- Performing data entry
- Preparing printouts, walking lists and other campaign materials
- Folding materials and stuffing and addressing envelopes
- Working with the candidate and keeping records of calls made to potential contributors
- Making trips to the post office and the county and state party headquarters
- Helping organize fund-raisers, participation in parades and other campaign activities
