Subject: Letter of Amendment to the October 27, 2008 Report

RE: Letter from Governmental Ethics Commission, dated September 9, 2009, subject: Receipts and Expenditures Report Due October 27, 2008 (Covering the Period July 25, 2008 thru October 23, 2008)

Dear Mr. Thornburg:

The referenced letter cited a total of \$920.24 of reimbursement expenses not fully explained. There were three checks written to Richard Miller for reimbursement of numerous campaign items charged to personal credit card and these are explained below:

Check # 541 in the amount of \$60.41 was for campaign parade supplies and fundraiser invitations charged to personal credit card at three vendors, each of which was less than \$50 and not itemized.

Check # 548 in the amount of \$373.27 for campaign expenses charged to personal credit card at six vendors. One exceeded the \$50.00 itemized limit to Copies 4 Less for Stickers for parades in the amount of \$190.99. The remainder of \$182.28 consisted of charges from the various vendors at various times for parade supplies, copies of letter and invitations to donors, each of which was less than \$50.00 and not itemized.

Check # 557 in the amount of \$486.53 for campaign expenses charged to personal credit card from eight different vendors at various times. Two charges exceeded the \$50 limit, to Sam's Club in the amount of \$112.38 for food supplies for fundraiser and WalMart in the amount of \$79.64 for food supplies for the fundraiser. The remaining \$294.51 was for various charges at various times, parade and party supplies, printing supplies, copies of flyers, each less than \$50 and not itemized.
