
Dear Mrs. Williams,

In response to your Notification of Material Error or Omission letter please be advised of the following:

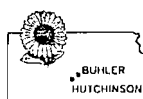
1. A check has been issued to the Kansas State Farm Insurance Agents in the amount of \$150.00.
2. In checking with the Kansas Chamber of Commerce, they show that the check in the amount of \$500 was not cashed and will be sending a letter with that information directly to you. We are assuming it was lost in the mail.
3. We have spoken to Luke Bell, with The Kansas Realtors PAC. He stated that check number 2692 in the amount of \$500 was issued on June 25th and cleared the bank on July 22nd. The second \$500 check was check number 2806 and was issued on August 18th and cleared the bank on September 4th. We are assuming that the wrong date was picked when entering the information on the computer for the second \$500 check. (See enclosed letter.)
