
Dear Ms. Renna:

In our telephone conversation last week you requested an explanation of the changes in the amounts of the contributions and expenditures from the original January 10, 2010, report to the amended January 10, 2010, report. This letter is an explanation accompanied by yet another amended cover sheet for the January 10, 2010, report showing totals which both you and I agree are now accurate.

1. The \$1000 expenditure to the State of Kansas listed on Schedule C of the January 10, 2010, report had been previously reported on the amended January 10, 2009, report as an expenditure of \$1000 to the Kansas Democratic House.
2. Bank interest of \$20.89 (included in the aggregate of \$149.59) was inadvertently reported again in Schedule A of the January 10, 2010, report. That amount had been previously reported on Schedule A of the amended January 10, 2009, report.
