To Whom It May Concern,


I wanted to make clear to the Kansas Ethics Commission that I inadvertently sent money to two different current campaigns in Kansas from my campaign account – one to Mosier for Kansas for \$150, and one to Yoder for Congress for \$100.

When I realized that I had done this and that I was not allowed to do so I contacted your office to get information as to what I must do to correct this mistake. This letter represents that correction.

As of today, April 28, 2010, two checks from my personal home checking account will deposit this money back into my campaign account - Check #3351 will be made out for \$150 representing the Mosier for Kansas amount and check #3352 will be made out for \$100 representing the Yoder for Congress.

Also, the Receipts & Expenditures report due on July 26, 2010 will reflect this adjustment and that these monies are being added back into my campaign account from my personal checking account.
