As Treasurer for Mike O'Neal, I am responding to your notice of April 29, 2010.

- (1) and (3) The \$500 ending balance difference between the 1/10/10 report and the 1/10/09 report results from the failure of the \$500 check to the Nemaha County Republican Central Committee to be received by them. We have determined that this check remains uncashed, have stopped payment on it and adjusted our books accordingly. We have amended the 1/10/09 report and have filed the amended report electronically 5/12/10.
