 Schedule C – Expenditures and Other Disbursements of that same report lists the disbursement of \$345.19 to a David Holloman, by check No. 104 dated July 23, 2010. The components of this disbursement are to reimburse Mr. Holloman for the following specific campaign expenditures advanced by him:

- a. \$64.38 paid by David Holloman to Jayhawk Signs & Graphics for a 36"x48" campaign sign;
