To Whom It May Concern:

I am the Treasurer of the "Christina Stein for State Representative" campaign in the 112th House District. As you know, Christina is the Democratic nominee for this office.

I received a "Notification of Material Error or Omission In a Receipts and Expenditures Report" on September 25, 2010. Enclosed please find the "Amended Report," together with this explanation.

When Christina accepted the \$60 donation from "Kansas Young Democrats" we were not aware that this group was one prohibited from giving donations during the legislative session. We have returned the \$60 to the Kansas Young Democrats.

Regarding the 5-25-10 donation from "International Union of Operating Engineers," our research revealed a clerical error. The donation was actually Received on 6-25-10---not 5-25-10, so it was received after the legislative session. (see attached copy.)

Also, we have removed the \$105 filing fee from the Schedule B for "In Kind Donations." Insofar as this amount was reimbursed to the candidate, it was listed on Schedule B in error.

Thanks you very much for pointing out these errors and allowing us to clear up any misunderstandings.
