Per our conversation of September 8, 2010, please consider this letter an amendment to the Receipts and Expenditures Report Due October 21, 2010 (Covering the Period July 23, 2010 thru October 21, 2010). The items noted as material errors or omissions are addressed below:



We reported that check as of July 15, 2010 on the Receipts and Expenditures Report Due July 26, 2010 as a contribution from the Johnson Co Kansans for Life. That check was deposited in our account on July 19, 2010.

  - a. The contribution dated July 6, 2010 to Michael Egan amounting to \$125 was incorrectly reported as having been received from Michael Egan. That contribution should have properly been reported as having been received by Donna Egan and should be noted as such.

- b. The contribution dated July 28, 2010 amounting to \$500 from John Lewis was incorrectly reported as having been received on July 28, 2010. That contribution should have properly been reported as having been received on September 21, 2010 and should be noted as such.
3. The items reported on Schedule D (Other Transactions) of the July 26, 2010 Receipts and Expenditures Report amounting to \$517.63 to Kelly Meigs should have been carried forward as loans payable to the October 25, 2010 Receipts and Expenditures Report. They should have been listed on Schedule D (Other Transactions) on the October 25, 2010 report as they were not repaid as until July 25, 2011.
