Re: Amended 10/25/10 report and final 1/10/11 report

Please find attached an amended 10/25/10 report and the final 1/10/11 report.

We have several amendments to our report on the 10/25/11 report which I will elaborate below and include sheets on. The final report sheet indicates a balance of \$276.36. Our checking account has a balance of \$26 so I am showing \$250 more revenue than I can account for on our checking account. I have done my best to identify this but have not been able to. I suspect we may have double counted a \$250 donation. If I am able to identify it I will contact you with an amended final report.

- 1. 9/16/10 Campaign Manager Kate Davis used \$55.42 to purchase refreshments for campaign workers. This will increase expenditures that amount.
- On page 1 of the original expenditure page on 10/25/10 a charge for a poll was inadvertently charged to Windsor Creek Group. The poll should have been listed for Kansans for a Democratic party. The amount of \$2,500 was correct so it will not have an effect on the overall expenditures.
- 3. On 8/24/10 the tax of \$47.48 was left off the charge from Printing and copying Pix. This will increase expenditures in that amount.
- 4. On 6/22/10 Verus bank debited the campaign checking account an amount of \$17.00. This will increase expenditures by that amount.
- 5. On 8/25/10 and expenditure was made for 51.42 at Dillons for Clipboards. This will increase expenditures by that amount.
- 6. On 9/1/10 the campaign paid Michael Vansickle \$425 for consulting and mileage. On 9/8/10 the campaign paid Michael Vansickle \$125.01. This will increase expenditures by both of those amounts respectively.
- 7. On 9/28/10 the campaign paid Printing and Copying Pix \$697.95 for campaign literature. This will increase expenditures by this amount.
- 8. The 10/17/10 expenditure of \$275 for canvassing services was inadvertently listed twice. This will reduce expenditures by \$275.

These changes will have the effect of increasing campaign expenditures on the 10/25/10 report by \$1,144.28. The included amended summary page reflects that.

Revenues:

- 1. Cecilia Blackwell was inadvertently listed twice on the report. She did not make a \$100 contribution on 10/4/10. This will lower revenues by \$100.
- 2. A 10/7/10 check for \$3,275 from Kansans for a democratic house was not in the original report. This was a refund because the campaign exceeded the contribution limit. This will increase revenues by \$3,275.

These changes will have a net effect of increasing campaign revenues by \$3,175. The included summary page reflects that.

Please find attached an amended 10/25/10 report and the final 1/10/11 report.

We have several amendments to our report on the 10/25/11 report which I will elaborate below and include sheets on. The final report sheet indicates a balance of \$276.36. Our checking account has a balance of \$26 so I am showing \$250 more revenue than I can account for on our checking account. I have done my best to identify this but have not been able to. I suspect we may have double counted a \$250 donation. If I am able to identify it I will contact you with an amended final report.

- 1. 9/16/10 Campaign Manager Kate Davis used \$55.42 to purchase refreshments for campaign workers. This will increase expenditures that amount.
- 2. On page 1 of the original expenditure page on 10/25/10 a charge for a poll was inadvertently charged to Windsor Creek Group. The poll should have been listed for Kansans for a Democratic party. The amount of \$2,500 was correct so it will not have an effect on the overall expenditures.
- 3. On 8/24/10 the tax of \$47.48 was left off the charge from Printing and copying Pix. This will increase expenditures in that amount.
- 4. On 6/22/10 Verus bank debited the campaign checking account an amount of \$17.00. This will increase expenditures by that amount.
- 5. On 8/25/10 and expenditure was made for 51.42 at Dillons for Clipboards. This will increase expenditures by that amount.
- On 9/1/10 the campaign paid Michael Vansickle \$425 for consulting and mileage. On 9/8/10 the campaign paid Michael Vansickle \$125.01. This will increase expenditures by both of those amounts respectively.
- 7. On 9/28/10 the campaign paid Printing and Copying Pix \$697.95 for campaign literature. This will increase expenditures by this amount.
- 8. The 10/17/10 expenditure of \$275 for canvassing services was inadvertently listed twice. This will reduce expenditures by \$275.

These changes will have the effect of increasing campaign expenditures on the 10/25/10 report by \$1,144.28. The included amended summary page reflects that.

#### **Revenues:**

- 1. Cecilia Blackwell was inadvertently listed twice on the report. She did not make a \$100 contribution on 10/4/10. This will lower revenues by \$100.
- 2. A 10/7/10 check for \$3,275 from Kansans for a democratic house was not in the original report. This was a refund because the campaign exceeded the contribution limit. This will increase revenues by \$3,275.

These changes will have a net effect of increasing campaign revenues by \$3,175. The included summary page reflects that.
