Per your request for information regarding Receipts and Expenditures Report Due Jan. 10, 2011 please note the following explanation.

Concerning the Builders Association of Kansas PAC reporting of a \$100 donation on 10/27/10, said check was not received by the campaign and a follow up with the Builders Association confirms that the check in question was never cashed. I believe they are amending their report.

The Schedule A report of a \$500 misreported check pertains to a payment made on Nov. 29, 2010 for payment of a Delta Airline Ticket (\$526.80) for a Foundation for Excellence in Education Convention, which was paid as a Visa payment from the campaign account but was also reimbursed to me by a scholarship payment from the Foundation. The \$500 reimbursement from the Foundation was put back into the campaign account on 12/31/10 and is shown on Schedule A as a deposit. The balance of \$26.80 was paid from the account.
