

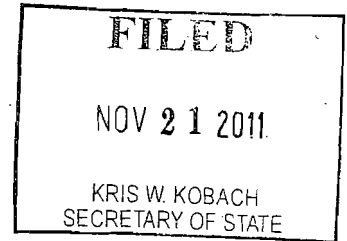

Dear Ms. Williams:

Thank you for your October 20, 2011 letter. In reviewing our records, we neglected to report a \$500 contribution to Christina's campaign from the Kansas Trial Lawyers Consumer/Civil Justice PAC.

Enclosed please find an amended Schedule "A", reflecting the \$500 donation which we received on 9-23-2011 from said PAC.

Also, enclosed please find an amended Summary Sheet reflecting the correction in Schedule "A." We are sending copies of the amended documents to you and to the Secretary of State on today's date by mail and facsimile.

You correctly state that the zero balance on the January 10, 2011 Termination Report is incorrect, as it omitted the extra \$500 that was received from this PAC.

As you recall, Christina Stein loaned her campaign \$2050.00. On 12/31/10, she repaid herself \$81.10 of that loan, leaving a balance of 1968.90 which Christina forgave.

As of today, the campaign has paid Christina back an additional \$500.00, thus leaving the balance owed to her by the campaign at \$1468.90. Christina Stein hereby forgives the debt of \$1468.90 owed to her by the campaign, leaving her termination balance at zero.

Thank you for pointing out our error and for allowing us to correct it.
