Dear Sir/Madam:

Per my conversation with Karina at your office today, I am sending this letter to re-communicate the details of the termination of my campaign account.

In January of 2011, I filed an annual report in person in Topeka, which you have. Immediately afterwards, I made two transactions from the campaign account in order to close it. I had a cashier's check made out for \$100 to the Kansas Democratic Party, and disbursed \$100 back to myself. This brought the total of the account to \$0.

The \$200 had been put into the campaign in two transactions: a donation from Ed Coleman of Topeka in the amount of \$100, and the initial money with which I opened the account out-of-pocket, which was recorded as coming from myself, the candidate, in previous campaign filings. Mr. Coleman's contribution was donated to the Kansas Democratic Party, and the initial \$100 was refunded to me. It is and was my understanding that this complies with Kansas ethics rules.

It is my understanding that this letter, upon faxing to you, will terminate the campaign account and any future reporting obligations.
