Dear Karina,

The purpose of this letter is to explain my finance report of July 30, 2012 and the amended return sent October 10, 2012.

1. The excess contribution from Nona Fitzwater on 7/21/12. I repaid the \$500.00 in a check to her on September 24, 2012; it will show on my October 29, 2012 report as an expenditure for the campaign.
2. The donation to the Republican House Campaign Committee was never cashed by the committee, even though I showed it as an expenditure on my 7/30/12 report. We amended the report to take this expenditure out and the check has been returned to me.
3. The loan payable to the Hoffman Family Trust was misreported on the 7/30/12 report as payable to me. That mistake was fixed on the amended return. I was unaware that this should have been paid back in August, until I received the notice on September 19, 2012 and talked to your office about it. It has now been paid back to the Trust as of September 24, 2012 and will show up on my October 29, 2012 as Paid in Full.
4. The final mistake was a subtraction error on loans payable to me. Too much was subtracted from the loan on the 7/30/12 report and has been fixed on the amended report.

Thank you for bringing these issues to my attention and I appreciate the help I received when I contacted you about them.
