I want to thank you for pointing out errors on this report. As you can see by the date received for the report, this was one hurried job on my part and I take total responsibility. I want to thank your staff who patiently went over the errors with me and am prepared to respond to the omissions and clerical mistakes:

The errors made in reporting the contributions to my campaign were made because of my lack of timely deposits of the contributions. I placed the date the deposits were made rather than the date the checks were received by my campaign. It is obvious the contributors are very knowledgeable as to the need to have timely donations before the end of the reporting period in July. Every contribution that is in error is from seasoned contributors who sent checks that arrived before the date shown for deposit and every error has the same date of deposit recorded in the report. I apologize for the error and those contributions should have shown up on the previous report rather than the one due in October.


2. The anonymous contribution of \$100 will show up as a \$100 contribution to a charity on my January report. Again, I am sorry for not realizing the limitation for anonymous contributions. I have been in office long enough, that should not be an issue.

3. To correct the error in reporting of contributions on deposit for 9-25, 2014. The check was from the Kansas Insurance Political Action Committee (INSPAC) PO box 55 Topeka, Kansas made out on 9-16, 2014. A deposit was made 10-05-2014 from Kansas Insurance Agents PAC 815 SW Topeka Blvd that was made out on Aug. 20, 2014. They are two separate organizations and contributions. Thank you for bringing that to my attention.

4. The reported payments made to Intrust Credit Card were: \$142.85 @ China Buffet in Emporia to reward walkers in the parade with lunch, \$162.57 for candy supplies for parades in Osage City, Olpe, Hartford, Burlington, Waverly, Lebo, Leroy, Melvern, and Gridley. It paid for travel to fundraisers for candidates in Topeka 5 times between 9-23 to 10-21 @ 116 miles per trip. \$324.80. During that time, I also attended the RCIL anniversary and walked doors in Osage City 102 miles, I attended the Coffey County Chamber in Burlington and walked doors in Burlington 93 miles. I walked in the Hartford parade and went door to door in Hartford 54 miles and attended the RHCC fundraiser @ Ellinwood for RHCC with Louie Gohmert. 185 miles.

5. I do keep a pretty good record of my travel and have sent you a copy of the record of my travel from just October 1 that pertains to my campaigning, speaking, and attending functions that pertain to the work I do. Please feel free to contact me with any further questions and again – thanks for your time and patience with someone who just got too impatient when I completed the original report.
