Dear Carol,

I received two letters from your entity regarding my filings. As they primarily stemmed from confusion in reporting last minute contributions, I have sought to fix the issues cited. However, there are a couple of outstanding items for which I may require your additional input or direction to remedy.

As to the contributions sent in the "last minute" window mentioned in Items 1 and 2 on Letter 1, I have added the Kansas Restaurant and Hospitality Association (\$500), the KS Builders' Association (\$250) and – although not mentioned, it also came in that timeframe and was not previously cited on the October 27, 2014 report – Ash Grove Cement (\$250). I had made a deposit for \$1000, which consisted of these three checks. Only KS Restaurant and Hospitality was reported on the last minute report as it reached the monetary threshold for reporting. All three checks are now included on the October 27, 2014 report in Schedule A as the letter from Ethics specifies should occur.

In Item 2 on Letter 1, it is cited that the KS Wine & Spirits Wholesalers PAC made a \$200 contribution. They did indeed send a check, but I did not accept or cash it.

As to Item 1 on Letter 2, the beginning balance listed on the January 10, 2015 reporting does now match the October 27, 2014 ending balance of \$18091.13 reported on the 10/27/14 report.

On Item 2 on Letter 2, please see the enclosed stubs which were both deposited and reported on the same deposit/report. In my notes included in this reporting, I show I had sent an email to you on the day I submitted the report. I have included that email exchange and am still in hopes I listed them correctly.

Concerning the primary Microsoft check, the letter inside and the check were very rumpled as though they'd gotten caught up in the mail. When they arrived to me, not in a Microsoft envelope, but rather in an envelope from the KS Republican House Campaign Committee, which was not rumpled and postmarked October 10, 2014, I presumed it had not made it to me the first time, was handed over to be resent to me and was later resent. That check probably arrived sometime around October 12, given the postmark. However, as October is a busy month in our business, I evidently did not pick up my PO Box – which is not at all unusual – for quite sometime. When I pulled the mail and opened it, I questioned it, sent you an email, and reported it datewise according to when I actually received it in my hands from my PO Box. If I need to how handle it differently, please let me know. Again, both checks were cashed.

Thank you for the opportunity to address these things. Please do let me know if I've not fully satisfied the items mentioned in your letters.
