1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Vickrey campaign reported receiving the following contributions:

All of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted contributions in excess of the legal limit amounting to \$500. We would suggest that these contributions be refunded immediately. **The return of these contributions should be noted on Schedule C (Expenditures and Other Disbursements) of the October 27, 2014 Receipts and Expenditures Report.**

2. Schedule A (Contributions and Other Receipts) of the July 28, 2014 report lists a \$25 contribution being received on 3-21-14 from Sherard Turf Farm. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. This contribution should not have been accepted and should be returned. **The return of this contribution must be shown on Schedule C (Expenditures and Other Disbursements) of the October 27, 2014 report.**

3. Schedule C (Expenditures and Other Disbursements) lists two expenditures being made to Laine Raitinger during the reporting period in the amount of \$1148.48 for reimbursement of expenses and \$5968.65 to Roderick Patton on 2-25-14. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage,

supplies, reimbursement for radio, newspaper, TV advertising, etc. If any one expense was over \$50 it must be itemized. This information can be disclosed in a letter of amendment to the July 28, 2014 report.
