- 1. The July 28, 2014 Receipts and Expenditures Report was not signed by the candidate or the treasurer. An amended July 28, 2014 report must be filed with the candidate's signature or the treasurer of record, Susan Koetters.
- 2. Schedule A (Contributions and Other Receipts) of the July 28, 2014 report contains a \$557.79 addition error. The contributions listed on Schedule A total \$17,226.10, not \$17,17,783.89 as listed on the front page summary sheet. This difference of \$557.79 must be explained in an amended report.
- 3. Schedule C (Expenditures and Other Disbursements) of the July 28, 2014 report contains a \$57.49 addition error. The expenditures listed on Schedule C total \$15,641.75, not \$15,699.24 as listed on the front page summary sheet.
