- 1. According to the reports filed with the Secretary of State, Kansas Credit Union PAC reports making a \$500 contribution to John Bradford on 10-9-14. This contribution was reported by your campaign as \$200, not \$500. If this contribution was \$500, an amended Schedule A (Contributions and Other Receipts) for the October 27, 2014 report must be filed. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the contribution was \$200, please note this fact in a letter to the Commission.
- 2. Schedule A (Contributions and Other Receipts) of the October 27, 2014 report lists a \$400 contribution from Kansas Citizens for Life, Liberty and Property PAC that was previously reported on the July 28, 2014 report. The PAC reports giving only one \$400 contribution to the Bradford campaign. An amended Schedule A for the October 27, 2014 report must be filed removing this duplicate entry.
- 3. Schedule A (Contributions and Other Receipts) of the October 27, 2014 report lists two, \$200 contributions from the Kansas Automobile Dealers PAC on 10-1-14 and 10-14-14. Schedule A also lists two, \$100 contributions from KS Manufactured Housing Industry PAC on 10-8-14 and 10-14-14. The PACs report giving only one contribution to the Bradford campaign. It appears these are duplicate entries and they must be removed from Schedule A (Contributions and Other Receipts) of the October 27, 2014 report.
