- 1. Schedule C (Expenditures and Other Disbursements) of the July 28, 2014 report lists a \$2000 loan repayment to Vern Swanson on 7-23-14. This \$2000 loan was never listed on Schedule A (Contributions and Other Receipts). An amended report must be filed listing the \$2000 in contributions from Vern Swanson.
- 2. Schedule D (Other Transactions) lists a \$500 loan payable to Vern Swanson on 5-21-14 and a \$1500 loan payable on 6-4-14. However, Schedule C (Expenditures and Other Disbursements) lists a loan repayment in the amount of \$2000 to Vern Swanson on 7-23-14. If these loans were repaid, an amended report must be filed removing the loans from Schedule D.
- 3. Schedule A (Contributions and Other Receipts) of the July 28, 2014 report lists a \$300 contribution on 7-16-14 from the Kansas National Education Association PAC. It appears this contribution is from the Konza Teachers PAC, not the Kansas National Education Association PAC since they gave only one \$500 contribution and it was reported by the campaign as received on 7-12-14. Konza Teachers PAC reported giving a \$300 contribution on 7-14-14 and that \$300 contribution is not reported by the campaign. Please check your records to determine if the \$300 contribution received on 7-16-14 was actually from the Konza Teachers PAC. If so, an amended Schedule A for the July 28, 2014 report must be filed correcting this error.
