According to the Candidate Last Minute Contribution Report filed on 8-1-14 by the Kasha Kelley campaign, the campaign received a \$500 contribution on 7-28-14 from the Kansas Restaurant & Hospitality Association. This contribution was not reported by your campaign on the October 27, 2014 report. This contribution must also be reported on Schedule A (Contributions and Other Receipts) on the October 27, 2014 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
- 2. According to the reports filed with the Secretary of State, Kansas Wine & Spirits Wholesalers PAC reports making a \$200 contribution to Kasha Kelley on 9-25-14.
