

1. According to the reports filed with the Secretary of State, PMCA Gas PAC reports making a \$250 contribution to Carolyn Bridges on 10/29/13. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2014 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.

2. Schedule D (Other Transactions) of the amended January 10, 2013 Receipts and Expenditures Report lists a loan payable on 11/10/12 totaling \$500 to Carolyn Bridges. This loan is not carried forward as a loan payable to the January 10, 2014 Receipts and Expenditures Report, nor is it disclosed on Schedule C (Expenditures and Other Disbursements). All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended January 10, 2014 report must be filed disclosing the disposition of this debt.

3. Schedule C (Expenditures and Other Disbursements) lists several expenditures with the date listed as various 2013 and no name and address for whom the expenditures were made. An amended Schedule C must be filed with the correct information and it will also be necessary for you to provide a more detailed description of the "campaign food" expenses in the amount of \$667.81 and the "campaign/legislative needs" in the amount of \$1362.47 which were paid from the campaign account. If any one expense was over \$50 it must be itemized.
