According to the reports filed with the Secretary of State, the Kansas Chamber of Commerce PAC reports making a \$500 contribution on 8-14-14 and Kansas Independent Business PAC reports making a \$300 contribution on 9-29-14. These contributions are not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2015 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.
- 2. According to the Candidate Last Minute Contribution Report filed on 7-31-14 by the Jeremy Alessi campaign, the campaign received a \$300 contribution on 7-30-14 from William Pickert. This contribution was not reported by your campaign on the October 27, 2014 report. This contribution must also be reported on Schedule A (Contributions and Other Receipts) on the October 27, 2014 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
- 3. Schedule D (Other Transactions) of the July 28, 2014 Receipts and Expenditures Report lists loans payable totaling \$280 to Jeremy Alessi.
