- 1. According to the reports filed with the Secretary of State, Kansans For Quality Mental Health Services PAC reports making a \$250 contribution to Bud Estes on 10-22-14. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 27, 2014 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. K.S.A. 25-4153 (a) (1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Estes campaign reported receiving a \$250 contribution on 11-19-13 from Nextera Energy Resources LLC, \$500 on 7-16-14 and an additional \$250 on 8-1-14, for a total of \$1000. All of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2016 Receipts and Expenditures Report.
