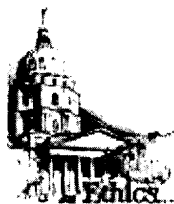


Regarding your August 31, 2016 letter on the two issues of Material Error and Omission:
