Re: Hughes for Kansas Material Error or Omission Dated March 29, 2017

Dear Ms. Williams

I am responding to the "Notification of Material Error or Omission In A Receipts and Expenditures Report" dated March 29, 2017 for the Hughes for Kansas campaign for state representative during 2016 in house district 21.

Item 1 in the notice was regarding a 7/22/16 check from Hallmark Cards in the amount of \$500. Although this was reported as a last minute contribution, the check was returned due to an error in the Hallmark accounting department. This is reflected in a returned check fee included on Schedule C in the amount of \$7.50. The returned check was never re-processed; therefore, it was not included in the October 31, 2016, report. If this was an incorrect procedure, please let me know how I can remedy this issue. Documentation from Hallmark can be provided if necessary.

Item 2 in the notice covered two checks, one dated 10/13/16 from Quality Mental Health Services PAC in the amount of \$250. This was, indeed, an omission, and the January 2017 report has been amended to reflect this. In making this correction, we also noted two additional errors. One was a check from Raise the Money in the amount of \$142.15. This check was never deposited and was deleted in the amendment. In addition, the bank fees charged to the campaign account were previously in error, and an additional expenditure in the amount of \$107.85 was added to reflect this.

The second check in Item 2, dated 10/7/16 from Kansas New Energy Economy PAC in the amount of \$400 was never received by the campaign. We can find no record of its receipt and therefore no record of its deposit. We suspect that although the PAC dated the check 10/7, it was not delivered prior to the election, and when the candidate lost, the check continued to be held.

The balance reflected in the amended report is \$0, and the campaign account is currently closed. Please let us know if there is further action needed to resolve these issues. We would appreciate the Commission noting that we have addressed these issues, from our perspective, by the 30-day deadline.
