1. According to the reports filed with the Secretary of State, the following PAC's report making contributions to the John Wilson campaign:

12-16-15	Kansas Medical Society PAC	\$250
12-21-15	Kansas Optometric PAC	\$500

These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2016 report. These errors will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

2. Schedule A (Contributions and Other Receipts) lists a \$200 contribution from the Kansas Insurance PAC on 10-1-15. The Kansas Insurance PAC does not report giving a contribution to the John Wilson campaign. However, according to the January 10, 2016 report filed by the Kansas Insurance Agents PAC, they report giving a \$250 on 10-1-15. It appears the \$250 contribution has been attributed to the wrong PAC. An amended Schedule A (Contributions and Other Receipts) must be filed listing the correct donor.

3. The Kansas Cable TV PAC reports giving a \$200 contribution to the John Wilson campaign on 9-29-15. However, the campaign reports it as a \$250 contribution. Please check your records to determine the amount of the contribution from the Kansas Cable TV PAC. If the contribution was for \$200, an amended Schedule A (Contributions and Other Receipts) must be filed with the correct amount. If the contribution was \$250, please indicate that fact in a note to the Commission.
