- 1. According to the Candidate Last Minute Contribution Report filed on 7-28-16 by the Dorothy Hughes campaign, the campaign received a \$500 contribution on 7-22-16 from Hallmark Cards, Inc. This contribution was not reported by your campaign on the October 31, 2016 report. This contribution must **also** be reported on Schedule A (Contributions and Other Receipts) on the October 31, 2016 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed.
- 2. According to the reports filed with the Secretary of State, the Kansas New Energy Economy PAC reports making a \$400 contribution to Dorothy Hughes on 10-7-16 and the Kansans For Quality Mental Health Services PAC reports making a \$250 contribution on 10-13-16.
