As provided by law, a copy of this notice has been made a part of your record in the Secretary of State's Office. The intentional failure to file an amended report within thirty (30) days is a class A misdemeanor. In addition, you may not accept contributions or make expenditures following the end of the thirty (30) day period if the amended report has not been filed.

Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. K.A.R. 19-29-3(a)(4) states that illegibility of a receipts and expenditures report is a material error or omission in a report. K.S.A. 25-4148 (e) further states that the Commission may require any treasurer to file an amended report for any period for which the original report filed by such treasurer contains material errors or omissions.

Section C of the cover summary page of the July 25, 2016 Receipts & Expenditures Report is not legible. An amended cover summary page must be filed which is readable.

2. The beginning balance on the July 25, 2016 Receipts & Expenditures Report is not the same as the ending balance of \$12,820.50 on the amended January 10, 2016 report. An amended report must be filed correcting this discrepancy.

3. Schedule A (Contributions and Other Receipts) and several entries on Schedule C (Expenditures and Other Disbursements) do not contain the city or state for addresses. The July 25, 2016 report must be amended to include the city and state for both schedules.

4. Schedule A (Contributions and Other Receipts) of the July 25, 2016 report lists 5 contributions that do not have the date that the contributions were received. An amended Schedule A must be filed with the date of receipt of all contributions.
