- 1. According to the January 10, 2016 report filed by the Kansas Chamber of Commerce Jobs PAC, they report giving a \$100 in-kind contribution for a voter list to the Willie Dove campaign. If the campaign received this voter list, an amended Schedule B (In-Kind Contributions) must be filed listing this in-kind contribution.
- 2. According to the reports filed with the Secretary of State, the Kansas Funeral Directors Association PAC reports making a \$150 contribution to Dove for Kansas House on 12-4-15. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2016 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 3. The January 10, 2016 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The January 10, 2016 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
- 4. According to the reports filed with the Secretary of State, the Leavenworth County Republican Central Committee reports receiving a \$150 donation on 11-7-15 from the "Campaign to Elect Willie Dove". This expenditure was not reported by your campaign. If this expenditure was made by the campaign, it must be reported on Schedule C (Expenditures and Other Disbursements) on the January 10, 2016 report. If the campaign did not make this expenditure, please note this fact in a letter to the Commission.
