1. Schedule A (Contributions and Other Receipts) of the October 31, 2016 report lists a \$250 contribution being received from the Shelter Insurance KS PAC 1 on 10-10-16. This contribution was also reported on the amended October 31, 2016 report you filed on January 8, 2017 as received on 10-26-16. It appears this \$250 contribution was reported twice since the Shelter Insurance KS PAC 1 reports giving only one \$250 contribution on 10-10-16. If it is a duplicate entry, an amended Schedule A for the October 31, 2016 report must be filed removing this entry.

2. Schedule D (Other Transactions) of the July 25, 2016 Receipts and Expenditures Report lists loans payable totaling \$3766.72 to Debbie Deere.
