1. According to the reports filed with the Secretary of State, the Farmers Insurance Employee and Agents PAC reports making a \$500 contribution to James Karleskint on 10-21-16 and HCA KS Good Government Fund reports making a \$250 contribution on 9-14-16. These contributions were not reported by your campaign. If these contributions were received, they must be reported on Schedule A (Contributions and Other Receipts) on the October 31, 2016 report. These omissions will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive these contributions, please note this fact in a letter to the Commission.

2. Schedule D (Other Transactions) of the July 25, 2016 Receipts and Expenditures Report lists a loan payable totaling \$2200 to James Karleskint. This loan is not carried forward as a loan payable to the October 31, 2016 Receipts and Expenditures Report, nor is it disclosed on Schedule C (Expenditures and Other Disbursements). All loans should be listed on Schedule D (Other Transactions) until such time as they are repaid or forgiven. An amended October 31, 2016 report must be filed disclosing the disposition of this debt.
