1. Schedule A (Contributions and Other Receipts) of the July 25, 2016 report lists a \$200 contribution being received on 5-30-16 from the Marlane A Morris Rev Liv Trust. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment (June 1, 2016) of the regular session of the legislature or any other time the legislature is in session. A \$500 contribution was also received from the Kansas NEA PAC on 6-23-16 which was during the time period of the special session on June 23 and June 24, 2016.

These contributions should not have been accepted and should be returned. The return of these contributions must be shown on Schedule C (Expenditures and Other Disbursements) of the October 31, 2016 report.

2. Schedule C (Expenditures and Other Disbursements) of the July 25, 2016 Receipts & Expenditures Report lists a \$120 expenditure on 1-26-16 for filing fee. This payment for the filing fee is also listed on Schedule B (In-Kind Contributions) as a loan to the candidate and on Schedule D (Other Transactions). If the candidate has not been paid for this loan for the filing fee, it must be removed from Schedule C (Expenditures and Other Disbursements) and should remain on Schedule B and Schedule D.

An amended report must be filed correcting the disposition of this debt.
