Dear Ethics Commission,

This letter is in response to your letter I received dated October 11, 2018 concerning Material Error or Omission in a Receipts and Expenditure Report due July 30, 2018.

The reverse side of your letter references 2 errors or omissions. Please find my response to each error or omission below:

1. According to the reports filed with the Secretary of State, the Kansas Beer Wholesalers PAC reports making a \$500 contribution on 7-5-18. I did not receive a contribution from the Kansas Beer Wholesalers PAC until October 15, 2018. The check I received on October 15, 2018 is dated 9-28-18. I have enclosed a copy of this check for your review. Since this check was received after July 30, 2018 it will be listed on my next Receipts and Expenditures report due October 29, 2018. I will not be amending the July 30, 2018 report concerning this contribution.

Also, according to the reports filed with the Secretary of State, the Kansas Credit Union PAC reports making a \$500 contribution on 7-5-18. I am certifying as of today's date, that no such contribution has ever been received by this campaign. Since no contribution from the Kansas Credit Union PAC was ever received, I will not be amending the July 30, 2018 report concerning this contribution.

2. The July 30, 2018 report did not disclose a payment to the Secretary of State for the candidate's filing fee. This fee was paid for by the candidate from personal funds and was omitted from the July 30, 2018 report by mistake. I have amended the July 30, 2018 report showing the filing fee on Schedule B as an "In-Kind" contribution from the candidate to the campaign.

I will assume my above response will correct the July 30, 2018 Receipts and Expenditure Report and will look forward to your response if it does not.
