 shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election.
 and an equal amount for each general election." The Koesten campaign reported receiving the following contributions:

All of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$1000. We would suggest that this contribution be refunded immediately. Since the campaign account is closed, it will be necessary for the candidate to personally reimburse Kathryn and Gary Bussing for this \$1000 excess contribution. A copy of the cancelled check must be provided to the Commission.

2. Schedule A (Contributions and Other Receipts) of the October 29, 2018 report listed a \$500 contribution from KTLA Consumer/Civil Justice PAC that was received by the campaign on 7-27-18. This contribution should have been shown on the Last Minute Contribution Report and filed with the Secretary of State on August 2, 2018.

In the future, you must be certain that any last minute contributions of \$300 or more are reported on the appropriate date. The failure to do so may result in a civil fine being assessed by the Governmental Ethics Commission.
