1. K.S.A. 25-4153 (a)(1) states, "The aggregate amount contributed to a candidate and such candidate's committee . . . shall not exceed the following: for member of the house of representatives, . . . \$500 for each primary election . . . and an equal amount for each general election." The Kathy Wolfe Moore campaign reported receiving a \$500 contribution on 6-29-18, and a \$500 contribution on 7-31-18, from the Kansas Medical Society PAC, for a total of \$1000. Both of these contributions were received during the primary election period.

Pursuant to K.S.A. 25-4153, the campaign accepted a contribution in excess of the legal limit amounting to \$500. We would suggest that this contribution be refunded immediately. The return of this contribution should be noted on Schedule C (Expenditures and Other Disbursements) of the January 10, 2020 Receipts and Expenditures Report.

2. According to the reports filed with the Secretary of State, the Kansas Transportation and Growth PAC reports making a \$500 contribution to Kathy Wolfe Moore on 10-24-18. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. **If the campaign did not receive this contribution, please note this fact in a letter to the Commission.**
