Additional information and assistance may be obtained by writing or calling this office. If after having contacted this office substantial issues remain unresolved, you may within ten (10) days of receipt of this notice request a hearing before the Commission.

1. The July 30, 2018 report did not disclose a payment to the Secretary of State for the candidate's filing fee. If the filing fee was paid by the candidate from personal funds, it should be recorded on Schedule B (In-Kind Contributions) as an "in-kind" contribution from the candidate to the campaign. If the filing fee was paid from campaign funds, this expenditure should be listed on Schedule C (Expenditures & Other Disbursements). The July 30, 2018 report must be amended by showing the payment of the filing fee either on Schedule B or Schedule C and on the cover summary page.
2. Schedule C (Expenditures and Other Disbursements) of the July 30, 2018 report lists \$636.21 in expenditures, however, the cover summary page indicates the total is \$649.46. An amended cover summary page must be filed with the correct totals.
3. Schedule B (In-Kind Contributions) of the July 30, 2018 report lists 2 in-kind contributions that are marked off on the page and the total for the in-kind contributions is not listed on line 6 of the cover summary page. If the in-kind contributions from Mr. & Mrs. Dave Johns and Mr. & Mrs. Robert Finley were made to the campaign, an amended Schedule B and cover summary page must be filed.
4. Schedule A (Contributions and Other Receipts) indicates your campaign accepted the following cash contribution over \$100:

K.S.A. 25-4153(i) states, "No person shall make any contribution or contributions to any candidate or the candidate committee of any candidate in the form of money or currency of the United States which in the aggregate exceeds \$100 for any one primary or general election, and no candidate or candidate committee of any candidate shall accept any contribution or contributions in the form of money or currency of the United States which in the aggregate exceeds \$100 from any one person for any one primary or general election."

The cash contribution listed above should not have been accepted by the campaign. In the future, you must be

certain that all contributions in excess of \$100 are made by check, cashier's check, money order or E Funds.
