- 1. According to the verified statements filed with the Secretary of State, Atmos Energy Corporation PAC reports making a \$150 contribution to Lonnie Clark on 9-7-18. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 2. The computer printout used for Schedule A (Contributions and Other Receipts) of the October 29, 2018 report does not contain a column indicating whether the contribution is in the form of cash, check, loan or funds/other. Each entry on Schedule A must be amended to reflect whether the contribution was made by cash, check, loan or e-file/other.
- 3. Schedule D (Other Transactions) lists a loan receivable in the amount of \$88.13 to Lonnie Clark on 9-21-18. The \$88.13 is also listed on Schedule C (Expenditures and Other Disbursements) of the October 29, 2018 report. If the loan has been paid, an amended Schedule D must be filed removing the \$88.13.
