- Schedule A (Contributions and Other Receipts) of the January 10, 2018 report lists a \$250 contribution received from the Physical Therapy Association PAC on 12-21-17. However, the Physical Therapy Association PAC reports giving a \$200 contribution to Sydney Carlin, not \$250. Please check your records to determine the amount of the PAC contribution. If the contribution is \$200, an amended Schedule A must be filed with the correct amount.
- Schedule C (Expenditures and Other Disbursements) of the January 10, 2018 report lists \$5422.44 in expenditures. However, Line 4 (Total Expenditures and Other Disbursements) of the front page summary sheet lists the amount as \$5386.44. An amended report must be filed correcting this \$36.00 error.
- 3. Schedule C (Expenditures and Other Disbursements) of the January 10, 2018 report lists a \$100 contribution to the Kansas Young Democrats on 10-26-17 for "campaign support". K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for the purchase of an advertisement in the committee's publications or for other reimbursable campaign expenses, that fact must be noted on an amended Schedule C. If this was an actual donation, the Kansas Young Democrats will be required to return your campaign funds or you will need to reimburse the campaign personally.
