1. Schedule C (Expenditures and Other Disbursements) of the January 10, 2019 report lists a donation to the Conservative Republicans of Western Johnson County in the amount of \$300 on 10-31-18.

K.S.A. 25-4157a does not list a contribution made to a political action committee as one of the permissible uses of a candidate's campaign fund. If this expenditure was for the purchase of an advertisement in the committee's publications or for other reimbursable campaign expenses, that fact must be noted on an amended Schedule C. If this was an actual donation, the Conservative Republicans of Western Johnson County will be required to return your campaign funds or you will need to reimburse the campaign personally. The return of this donation must be shown on Schedule A (Contributions and Other Receipts) on the January 10, 2020 report.

2. Schedule C (Expenditures and Other Disbursements) lists an expenditure to Erik Turek during the reporting period in the amount of \$1,221.04 for reimbursement. It will be necessary for you to provide a more detailed description of the types of expenses which were reimbursed, i.e., mileage, meals, postage, supplies, etc. If any one expense was over \$50 it must be itemized. This information can be disclosed in a letter of amendment to the January 10, 2019 report.
