- 1. Schedule A (Contributions and Other Receipts) of the January 10, 2018 report lists a \$200 contribution being received on 1-3-17 from the Kansas Dental PAC. K.S.A. 25-4153a states that no registered lobbyist, political committee or person, other than an individual, shall make a contribution and no legislator or candidate for the legislature shall accept a contribution from a lobbyist, political committee or person, other than an individual after January 1 and prior to sine die adjournment of the regular session of the legislature or any other time the legislature is in session. This contribution should not have been accepted and should be returned. The return of this contribution must be shown on Schedule C (Expenditures and Other Disbursements) of the July 30, 2018 report.
- 2. According to the reports filed with the Secretary of State, the Kansas Association of Nurse Anesthetists PAC reports making a \$350 contribution to Troy Waymaster on 12-18-17. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the January 10, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 3. According to the reports filed with the Secretary of State, the Republican House Campaign Committee reports receiving a \$1000 contribution from Troy Waymaster on 7-17-17. This expenditure was not reported on Schedule C (Expenditures and Other Disbursements) on the January 10, 2018 report. If this expenditure was made, it must be reported on Schedule C on the January 10, 2018 report. If the campaign did not make this expenditure, please note this fact in a letter to the Commission.
