Schedule A (Contributions and Other Receipts) of the October 29, 2018 report lists a \$500 contribution on 7-27-18 from the Farmers Employee & Agent PAC of Kansas that was previously reported on the amended July 30, 2018 report. An amended October 29, 2018 report must be filed removing this duplicate entry.
- 2. According to the reports filed with the Secretary of State, the Kansas Wine & Spirits Wholesalers PAC reports making a \$200 contribution to Leonard Mastroni on 9-20-18. This contribution was not reported by your campaign. If this contribution was received, it must be reported on Schedule A (Contributions and Other Receipts) on the October 29, 2018 report. This error will cause the cash balance on the front page summary sheet to be incorrect. Therefore, an amended front page summary sheet must also be filed. If the campaign did not receive this contribution, please note this fact in a letter to the Commission.
- 3. Schedule A (Contributions and Other Receipts) of the October 29, 2018 report lists two PAC contributions with the type of payment noted as "cash". If these were typing errors and not actual "cash" contributions, please amend the report to indicate the correct type of payment. If they were in fact "cash" contributions, these contributions in excess of \$100 should not have been accepted. Please be certain that all contributions in excess of \$100 are made by check, cashier's check, money orders or E-Funds.
